- Delivery Period:** 06 weeks from the date of receipt of order by the supplier to the consignee attached.
- Pre-Dispatch Inspection:** Supplier shall make necessary arrangement / facilitate to carry out Pre-Dispatch inspection as per Tender Terms & condition and submit the Inspection report to this office. The Pre-Dispatch inspection cost will be borne by supplier. Machine should be dispatched only after satisfactory Pre-Dispatch Inspection.

- 4 **Risk purchase clause:** If the bidder fails to supply the stores within the stipulated delivery period, the order will stand cancelled. Undersigned shall be entitled to purchase such stores from any other source at such price which ordinarily should not be more than 10% of the tender price. The extra expenditure in such cases shall be recovered by Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd. (Procurement Cell), Mumbai from the Supplier.
- 5 **Payment Terms:** Payment of 100% of the contract value will be made within 8 weeks on delivery and successful installation and satisfactory commissioning and operation of the machinery.
- 6 **Acceptance & Receipt:** It should be submitted in Appropriate Format to the purchasing authority.
- 7 **Delivery Challan** - Should be sent in the name of consignee in duplicate. It should specify Name of Equipment / Mfg. by / packing & quantity.
- 8 **Invoice Copy** - Should be sent in triplicate on the Name of Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd.(Procurement Cell), Mumbai. Along with Bill of Entry and Country of Origin Certificate of the consignment.
- 9 **Other Terms :**
 - 1) **Warranty:** The warranty period shall be for 2 years from the date of commissioning of all equipment supplied as certified by the consignee. After completion of 2 years warranty period Manufacturer/Supplier should give commitment to ensure services and supply of spare part for further 8 years. The successful tenderer must ensure 95% uptime during warranty period. In case of downtime, warranty period will be extended for period of downtime. If the equipment is not attended within 24 hours for Mumbai and 48 hours for other places the supplier will be liable to pay a penalty of 0.07% of purchase cost for every day of delay. Such penalty will be recovered from the amount of security deposit. Certificate of such uptime / downtime issued by the end user will be binding for the supplier Replacement of spares parts thereof due to manufacturing defects during warranty period will be entirely at the supplier's cost.
 - 2) The user institution will enter to the Comprehensive Maintenance Contract with supplier agency @ 5% of the order value (excluding taxes) of the equipment per year for 8 years after completion of warranty period. In case of non-compliance of CMC the supplier will be liable to pay penalty or for appropriate action. Payment of CMC on yearly basis will be made by the user's institution, at the end of the year after satisfactory performance report from the end user.
- 10 **Contract Agreement:** Bidder should submit Contract Agreement on non-judicial stamp paper of requisite value.



Specifications for O. T. Table
1. Universal Mobile Electro-hydraulic Operation Theatre Table for performing Gynaecology Surgery in Adult patient.
2. All below functions of the table should be operated through electrohydraulic powers actuator adjustable via corded backlit display hand controller box for easy access from outside the surgical area.
<ul style="list-style-type: none"> a) Height adjustment b) Back rest up / down movement c) Lateral tilts d) Trendelenburg / Reverse Trendelenburg e) "O" position activated by single button for fast and easy levelling Flex & reflex individual function switches should be available on the hand control.
3. It should also have service LED with audible alarms to alert the use in case of technical problem aroused in the table due to internal electronic fault which could lead to intra-operative breakdown during surgical procedure.
4. In case of tables top sectional conflict condition, the interlock controller should stop and prevent damage by stopping further moment of the table top section and should give audio visual alarm with error code display guiding the user to prevent the conflict thus avoiding major breakdown in the table.
5. Override Controller Additionally manual function selector cum electronic override controller should be available at the base of the table towards the head side to help the user to select the functions and operate them intra operatively in the event of major hand control, electrical or battery failure.
6. Built in Error code Display for self-diagnosis and Communication Port located on the Base or column for external communication
7. Battery power supply 24 V with charger built in the table base
8. Total length min:2160 mm +/-5%
9. Total width min:508mm or better
10. The table top should be C-Arm compatible and should have side rails for installation of standard and additional accessories listed separately here as per the surgical positioning requirements faculty wise.
11. Table-top adjustment minimum vertical height from the floor: 655mm with tolerance of +/-5% without mattress for use in universal surgical applications.
12. Electro-hydraulically powered Back rest movement: 70 ⁰ up/40 ⁰ down or better.
13. Head rest manually adjusted:- 90 ⁰ Down and 20 ⁰ up.
14. Following are the Electro-hydraulic movements operated via corded hand controller as under
15. Lateral tilt or side tilt: 20"right & left side with tolerance of +/-10%
16. Trendelenburg/Reverse-Trendelenburg position adjustment, 30 each
17. Leg rest manual adjustment min: -90"down and 20° up.
18. Detachable Leg rest plates with possibility of abduction of 90° to the side
19. Five section Table-top consists of following sections: head rest, back. rest, Divided or single seat Section with peri anal cut-out, Two-part adducible and detachable leg sections

20. Head rest & Leg rests are manual adjustments by gas spring assisted ratchet for easy & fall safe movements.
21. High mobility with antistatic four wheels at the base for relocation of the table. it consists of two swivel able castors and two straight wheels for easy movements of the table in OR.
22. Locking unlocking of the base should be possible with simple to operate, single foot lever pedal on the side of the base with two manual adjustable floor locks which gives uncompromised grip on to the floor thus providing high stability of the top.
23. All external construction elements including base cover should be made up of high grade rust proof medical grade stainless steel material.
24. The SFC foam mattress should be covered by latex free, flexible, Antistatic, seamlessly welded, fire proof material, resistance against disinfecting agents used in the OR.
25. Minimum Dynamic patient loading capacity = 285 kg acceptable +/- 5% in all articulated positions
26. The Table should facilitate Normal & Reverse orientation for achieving easy imaging of the upper body which eliminates the requirement of using additional table top, thus reducing inventory and complex assembly for the OR staff.
27. General accessories include Head Rest, Pair of leg Plates which are hinged and adducible, with min thickness of 50mm SFC memory foam padding for bed soar management.
28. Table must enable possibility of taking X-ray images on whole length of tabletop along with Live C-arm monitoring of patient as and when need arises. Particularly:- table top should be X-ray translucent, mounted to the table column, without transversal metal beams for taking of x-ray pictures using the universal X-ray tray which slides throughout its length in the tunnel provided below the table top
29. Built in Battery Backup up of 50 operations with single charge avoids the need of connecting mains cable during the surgical procedure hence reduces the chances of cross infections due to mains cable lying on the floor and also prevents topping of the OT staff
30. Should have IP-X4 degree of protection against ingress of fluids with Class I protection against electrical shocks.
31. The product should be certified under IEC 60601-1-1-2:2001 Electromagnetic Compatibility as certified by Electronics Testing Center and should be certified under highest degree of international safety certification under European CE or US FDA Good Manufacturing Practices Regulations 21CFR820 for Medical Devices.
