As per above mentioned subject and reference the bid for Triple Layer Face Mask which was floated on GeM Portal was finalized and purchase orders was allotted to you as per reference no 2 on dated 07/11/2020 for 80,00,000pcs.

As per reference no 13 show cause notice was issued regarding non supply of Triple Layer Mask for COVID 19 and reply was asked about the same. As per reference no 14 your reply for show cause was received, which mentioned that the rate was inadvertently and unintentionally quoted as Rs 0.78/- per piece by one of your employee in place of Rs 1.78/- per piece, which was unsatisfactory. As a result you are called for hearing as per reference no15, which was unsatisfactory.

Your decision not to honour the agreed tender condition, by flouting the responsibility as the L1. Even thereafter, you have not supplied the Item as per purchase order.

As per the Terms & Conditions of the tender, you are blacklisted with immediate effect as per procurement policies of HBPCL for the period of next 1 year to participate in Tenders.
