- 10% of the tender price, unless otherwise properly satisfied by purchasing officer. The extra expenditure in such cases shall be recovered by Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd.(Procurement Cell), Mumbai from the Supplier inclusive of recovery by Revenue recovery procedure.
4. **Payment Terms :** 100 % Payment shall be paid on receipt & acceptance of stores in good conditions by the consignee
 5. **Labelling:** The word **"FOR GOVERNMENT OF MAHARASHTRA NOT FOR SALE"** should be printed on each unit pack in readable Purple or Green Colours.
 6. **Acceptance & Receipt:** In prescribed format. It should be submitted in Original Certificate copy to the purchasing authority along with triplicate copies of the Invoice.
The acceptance letter will be jointly signed by the institution mentioned in Billing address as well as shipping address of the consignee list. Hon. Commissioner D.M.E.R and supplier should ensure that the acceptance certificate is endorsed by the institute mentioned in the billing address to insure that the abstract Bill of the same can be settled.
 7. **The Consignees upon Receipt of the material should issue acceptance certificate within 7 days of receipt of material in Two copies.  8. **Analysis Report :** Manufactures should submit copy of Valid WHO GMP Certificate, No conviction certificate, and Drugs analysis report from NABL Accredited Labs to each consignee for each batch supplied with copy of the same along with invoice to Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd.(Procurement Cell), Mumbai.
 9. **Delivery Challan** – Should be sent in the name of consignee in duplicate. It should specify Name of Drugs/ Mfg's Name. by / Expiry Date / packing & quantity.
Invoice Copy – Should be sent in triplicate on the Name of Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd.(Procurement Cell), Mumbai
 10. **Other Terms ::** As per Tender terms & conditions
Fall Clause: It is a condition of the contract that all through the currency there of, the price at which you will the supply stores should not exceed the lowest price charged by you to any customer during the currency of the rate contract and that in the event of the prices going down below the rate contract prices you shall promptly furnish such information to us to enable to amend the contract rates for subsequent supplies.
 11. The drugs shall have the active ingredients at the maximum permissible level throughout the shelf life period of the drug. The supplies will be deemed to be completed only upon receipt of the quality Control reports from the Govt. approved laboratories. Samples which do not meet quality requirements shall render the relevant batches liable to be rejected. If the sample is declared to be Not of Standard Quality or spurious or adulterated or miss branded during the shelf life , such batch/batches will be deemed to be rejected goods. The Purchaser shall be the final authority to reject full or any part of the supply, which is not conforming with the specifications and other terms and conditions. No payment shall be made for rejected supply. Rejected items must be removed by the tenderers within two weeks of the date of rejection at their own cost and replaced immediately at their

own cost. In case rejected items are not removed it will be destroyed at the risk, responsibility & cost of Manufacturer. Disposal of defected/substandard goods should be under intimation and as per the instructions from FDA. Recovery on account of supply of substandard medicines will be whole amount of payment made i.e. Full quantity of substandard batch(s) irrespective of quantity used/not used.


