- 11. The drugs shall have the active ingredients at the maximum permissible level throughout the shelf life period of the drug. Samples which do not meet quality requirements shall render the relevant batches liable to be rejected. If the sample is declared to be Not of Standard Quality or spurious or adulterated or miss branded during the shelf life, such batch/batches will be deemed to be rejected goods. The Purchaser shall be the final authority to reject full or any part of the supply, which is not conforming with the specifications and other terms and conditions. No payment shall be made for rejected supply. Rejected items must be removed by the tenderers within two weeks of the date of rejection at their own cost and replaced immediately at their

own cost. In case rejected items are not removed it will be destroyed at the risk, responsibility & cost of Manufacturer. Disposal of defected/substandard goods should be under intimation and as per the instructions from FDA.
