- 3. Risk purchase clause: If the supplier fails to supply the stores within the stipulated delivery period inclusive of period with penalty, the order will stand cancelled. Undersigned shall be entitled to purchase such stores from any other source at such price, which ordinarily should not be more than 10% of the tender price, unless otherwise properly satisfied by purchasing officer. - 5. Labelling: The word "FOR GOVERMENT OF MAHARASHTRA NOT FOR SALE" should be printed on each unit pack in readable Purple or Green Colours.
- 6. Acceptance & Receipt: In prescribed format. It should be submitted in Original Certificate copy to the purchasing authority along with triplicate copies of the Invoice.

 The acceptance letter will be jointly signed by the institution mentioned in Billing address as well as shipping address of the consignee list. Hon. Commissioner D.M.E.R and supplier should ensure that the acceptance certificate is endorsed by the institute mentioned in the billing address to insure that the abstract Bill of the same can be settled.

- Delivery Challan Should be sent in the name of consignee in duplicate. It should specify Name of Drugs/ Mfg's Name/ Mfg Date / Expiry Date / packing & quantity.

- 10. Other Terms :: As per Tender terms & conditions
 Fall Clause: It is a condition of the contract that all through the currency there of, the price at which you will the supply stores should not exceed the lowest price charged by you to any customer during the currency of the rate contract and that in the event of the prices going down below the rate contract prices you shall promptly furnish such information to us to enable to amend the contract rates for subsequent supplies.
- 11. The drugs shall have the active ingredients at the maximum permissible level throughout the shelf life period of the drug. The supplies will be deemed to be completed only upon receipt of the quality Control reports from the Govt. approved laboratories. Samples which do not meet quality requirements shall render the relevant batches liable to be rejected. If the sample is declared to be Not of Standard Quality or spurious or adulterated or miss branded during the shelf life, such batch/batches will be deemed to be rejected goods. The Purchaser shall be the final authority to reject full or any part of the supply, which is not conforming with the specifications and other terms and conditions. No payment shall be made for rejected supply. Rejected items must be removed by the tenderers within two weeks of the date of rejection at their own cost and replaced immediately at their own cost. In case rejected items are not removed it will be destroyed at the risk, responsibility & cost of Manufacturer. Disposal of defected/substandard goods should be under intimation and as per the instructions from FDA. Recovery on account of supply of substandard medicines will be whole amount of payment made i.e. Full quantity of substandard batch(s) irrespective of quantity used/not used.
