The Pre-Dispatch inspection cost will be borne by supplier. Machine should be dispatched only after satisfactory Pre-Dispatch Inspection.
- Risk purchase clause:** If the bidder fails to supply the stores within the stipulated delivery period, the order will stand cancelled. Undersigned shall be entitled to purchase such stores from any other source at such price which ordinarily should not be more than 10% of the tender price. The extra expenditure in such cases shall be recovered by Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd.(Procurement Cell), Mumbai from the Supplier.
- Payment Terms:** 100 % Payment shall be paid on receipt, Complete Installation (acceptance) of Machine in good conditions by the consignee.

- Acceptance & Receipt:** It should be submitted in Appropriate Format to the purchasing authority.



It should deliver blood and intravenous fluid to the patient at normo-thermic temperature at wide range of flow rates from gravity flow rates to 50-5000 ml/hr.

It should avoid patient line cooling down and temperature of blood and fluid should be maintained at normo-thermic range.
Single step programming of warmer
Easy to setup and easy to use
It should display set point of recirculating reservoir
Audible and visual alarms if reservoir temperature reaches 43.9° C
Meets all AMERICAN ASSOCIATION OF BLOOD BANK standards for blood warming
Blood & fluid should remain in closed system

Disposables must be latex free if disposables are being used. 100 reusable tubings per machine should be provided
Should have built in safety audio and visual alarms for secure connection, Over Temperature etc.
