The Pre-Dispatch inspection cost will be borne by supplier. Machine should be dispatched only after satisfactory Pre-Dispatch Inspection.

- 4 **Risk purchase clause:** If the bidder fails to supply the stores within the stipulated delivery period, the order will stand cancelled. Undersigned shall be entitled to purchase such stores from any other source at such price which ordinarily should not be more than 10% of the tender price. The extra expenditure in such cases shall be recovered by Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd. (Procurement Cell), Mumbai from the Supplier.
- 5 **Payment Terms:** Payment of 100% of the contract value will be made within 8 weeks on delivery and successful installation and satisfactory commissioning and operation of the machinery.
- 6 **Acceptance & Receipt:** It should be submitted in Appropriate Format to the purchasing authority.
- 7 **Delivery Challan** - Should be sent in the name of consignee in duplicate. It should specify Name of Equipment / Mfg. by / packing & quantity.
- 8 **Invoice Copy** - Should be sent in triplicate on the Name of Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd.(Procurement Cell), Mumbai. Along with Bill of Entry and Country of Origin Certificate of the consignment.
- 9 **Other Terms :**
 - 1) **Warranty:** The warranty period shall be for 2 years from the date of commissioning of all equipment supplied as certified by the consignee. After completion of 2 years warranty period Manufacturer/Supplier should give commitment to ensure services and supply of spare part for further 8 years. The successful tenderer must ensure 95% uptime during warranty period. In case of downtime, warranty period will be extended for period of downtime. If the equipment is not attended within 24 hours for Mumbai and 48 hours for other places the supplier will be liable to pay a penalty of 0.07% of purchase cost for every day of delay. Such penalty will be recovered from the amount of security deposit. Certificate of such uptime / downtime issued by the end user will be binding for the supplier Replacement of spares parts thereof due to manufacturing defects during warranty period will be entirely at the supplier's cost.
 - 2) The user institution will enter to the Comprehensive Maintenance Contract with supplier agency @ 5% of the order value (excluding taxes) of the equipment per year for 8 years after completion of warranty period. In case of non-compliance of CMC the supplier will be liable to pay penalty or for appropriate action. Payment of CMC on yearly basis will be made by the user's institution, at the end of the year after satisfactory performance report from the end user.
- 10 **Contract Agreement:** Bidder should submit Contract Agreement on non-judicial stamp paper of requisite value.

Fall Clause

Specification of Pediatric Semi Fowler Bed.

- A. Overall Size Buffer to Buffer :- Approx. 1540 mm L x 860 mm W x 490 mm To 730 mm H
(Without Mattress)
- B. Mattress Platform Size :- 1335 mm L x 680 mm W.
- C. Construction: Bed frame is made up of 60mm x 30mm x16G or more CRCA rectangular tubes with horizontal supports in 19 x 19 x 1.25mm thick ERW tube.
- D. Two section 1.2 mm (18 G) CRCA M.S perforated sheet top for easy breathing of mattress. Fixed Body rest made from 1.2 mm (18 G) M.S CRCA perforated sheet.
- E. Backrest section is welded to 25.4mm diameter x 16G ERW tube, Extra support to be provided below the back section for additional strength and properly connected to the linkage which hold the screw mechanism.
- F. The back rest can be operated with the help of lead screws and crank. Lead screws should be roll formed. It should be functioning on the basis of Synchronized Linear Roller Mechanism (SLRM).
- G. The handle should be foxed to the bed and should be made for 303 grade S.S. The handle should collapse inside to minimize obstruction when not in use.
- H. The fixed section are welded to the frame in such a way that there is no gap between the fixed panel and the bed from inside.
- I. The bed is provided with full length railings on either side with frame made from 25.4mm dia ERW tube and 19mm OD vertical tubes. Sliding facilitated on 19mm round S.S. Bar.
- J. Head end and foot end bows to be made from 40mm x 30mm x18gauge ERW tube with PLB board 12mm thick with aesthetic polycarbonate Printed labels on either sides.
- K. The bows are fitted to the beds with help of 10mm Nut bolt.
- L. The bed should be provided with four no's non rusting high strength engineering molded 125mmdia. Set of diagonal locking castors with directional locking
- M. The Wheel TPE should have chemical stability, Good UV resistance, Anti-ageing & yellowing resistance and corrosion resistance. Castor housing should be 2.5mm thick ASTM, A36MILD steel. Shell in ABS plastic 2mm thick anti impact, Anti winding.
- N. The end of legs provided with Nylon shoes having metal inserts.

- O. Finish: All components should be pretreated in separate eight tank process for better finish, good adhesion and corrosion protection. Process includes Hot Degreasing, Derusting, Activation, Phosphating & no's of water rinses as per IS 3618-1966 class 'C' type and them pretreated materials is coated with epoxy powder with film thickness of 60 microns (approx.) and then oven baked at 180 degree centigrade.
- P. Manual adjustments: Backrest and trendelenberg / Reverse trendelenberg through two screw systems with trust bearings individually manoeuvred by a single handle.
- Q. Castor wheels made from high grade non floor-staining synthetic materials with integrated thread guards. Wheel centre having precision ball bearing to run smoothly.
- R. Safe working Load – 110 kg & Patient bearing load capacity 90 K
- S. Raised Backrest Angle - $70^{\circ} \pm 5^{\circ}$, Trendelenburg - $10^{\circ} \pm 2^{\circ}$, reverse Trendelenburg - $8^{\circ} \pm 2^{\circ}$
- T. All Process Parameters to be as per documented IMS Procedures for Quality Assurance (.ISO 9001:2015, ISO 14001:2015, OHSAS 18001:2007 & ISO 13485:2016 Quality Management Systems).
