The Pre-Dispatch inspection cost will be borne by supplier. Machine should be dispatched only after satisfactory Pre-Dispatch Inspection.

- 4 **Risk purchase clause:** If the bidder fails to supply the stores within the stipulated delivery period, the order will stand cancelled. Undersigned shall be entitled to purchase such stores from any other source at such price which ordinarily should not be more than 10% of the tender price. The extra expenditure in such cases shall be recovered by Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd. (Procurement Cell), Mumbai from the Supplier.
- 5 **Payment Terms:** Payment of 100% of the contract value will be made within 8 weeks on delivery and successful installation and satisfactory commissioning and operation of the machinery.
- 6 **Acceptance & Receipt:** It should be submitted in Appropriate Format to the purchasing authority.
- 7 **Delivery Challan** - Should be sent in the name of consignee in duplicate. It should specify Name of Equipment / Mfg. by / packing & quantity.
- 8 **Invoice Copy** - Should be sent in triplicate on the Name of Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd.(Procurement Cell), Mumbai. Along with Bill of Entry and Country of Origin Certificate of the consignment.
- 9 **Other Terms :**
 - 1) **Warranty:** The warranty period shall be for 2 years from the date of commissioning of all equipment supplied as certified by the consignee. After completion of 2 years warranty period Manufacturer/Supplier should give commitment to ensure services and supply of spare part for further 8 years. The successful tenderer must ensure 95% uptime during warranty period. In case of downtime, warranty period will be extended for period of downtime. If the equipment is not attended within 24 hours for Mumbai and 48 hours for other places the supplier will be liable to pay a penalty of 0.07% of purchase cost for every day of delay. Such penalty will be recovered from the amount of security deposit. Certificate of such uptime / downtime issued by the end user will be binding for the supplier Replacement of spares parts thereof due to manufacturing defects during warranty period will be entirely at the supplier's cost.
 - 2) The user institution will enter to the Comprehensive Maintenance Contract with supplier agency @ 5% of the order value (excluding taxes) of the equipment per year for 8 years after completion of warranty period. In case of non-compliance of CMC the supplier will be liable to pay penalty or for appropriate action. Payment of CMC on yearly basis will be made by the user's institution, at the end of the year after satisfactory performance report from the end user.
- 10 **Contract Agreement:** Bidder should submit a tripartite (Importer, Manufacturer and Haffkine Bio Pharmaceutical Corporation Ltd.) Contract Agreement on non-judicial stamp paper of requisite value.

Fall Clause

1. Fully automated complete walk away slide container with option of delay start for IHC, ISH & FITC.
 2. Automation-from banking to counter staining should be on board.
 3. Third party primary antibody should be able to perform as a titration method.
 4. Compatibility for paraffin (dewaxed), and frozen sections as well as cytology smears.
 5. Should be capable of running more than 3 to 4 staining protocols in a single run.
 6. Should have throughout of at least 20 or more than 20 sliders at a time.
 7. IHC run time should not be more than 3.5 hour.
 8. Antibody consumption per slide should not be more than 100µlit.
 9. It should be open for third party primary antibody.
 10. It should be to perform test as well as control on same slide without any extra consumption of reagents.
 11. Should have a liquid cover slip and air vortex technology for homogenous binding of the Antibody.
 12. The system should have built in Antigen Retrieval System & not a separate module system.
 13. Instrument should have both low pH and high pH for Antigen Retrieval
 14. Should have a slide Labelling System (Barcode reader/printer)
 15. Should have facility of individual programming for each slide with any protocol.
 16. Should have humidity and temperature regulation for operation between 37°C-100°C and 10-90% humidity.
 17. Should be compatible for use with standardized protocols or user defined protocols.
 18. Should come with compatible computer and software.
 19. The software should be upgradable.
 20. The Reagent carousel holds at least 25 ready to use reagent container.
 21. Instrument should be able to do FDA approved Pd-L1 (SP142), ALK (D5F3), Her2/hue etc.
 22. Instrument should be able to perform CISH like EBER, Kappa, Lambda etc.
 23. Instrument should be able to perform FDA approved DDISH for Her2nu.
 24. Instrument should be able to perform Alkaline Phosphate Fast Ted chromogenic for tissue samples.
 25. Instrument should have the capability to run different protocols at the same time in a single run like different antigen retrieval timings.
 26. Instrument should have the capability to run both the DAB & Red detection at the same time in a single run.
 27. Instrument should have the capability to perform dual stain single stain in a single run.
 28. Price of detection kits and reagents consumables should be sealed for 5 years.
 29. Company should provide operators training Instrument qualification, operation qualification, performance qualification, training certificate, at free of cost.
 30. Regents for processing 500 IHC Test must be supplied free of cost with instrument.
 31. Primary Antibodies 50 tests each of ER, PR, Her2Neu, Ki-67, (50X4-200 Free)
 32. The supplier/Tenderer must supply Positively Charged slides, Air conditioner for the laboratory, table for computer.
 33. UPS back up for at least 1 hour should be provided along with the system.
