The Pre-Dispatch inspection cost will be borne by supplier. Machine should be dispatched only after satisfactory Pre-Dispatch Inspection.

- 4 **Risk purchase clause:** If the bidder fails to supply the stores within the stipulated delivery period, the order will stand cancelled. Undersigned shall be entitled to purchase such stores from any other source at such price which ordinarily should not be more than 10% of the tender price. The extra expenditure in such cases shall be recovered by Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd. (Procurement Cell), Mumbai from the Supplier.
- 5 **Payment Terms:** Payment of 100% of the contract value will be made within 8 weeks on delivery and successful Installation and satisfactory commissioning and operation of the machinery.
- 6 **Labelling:** The word "**For use of GOVERNMENT OF MAHARASHTRA NOT FOR SALE**" should be printed on each unit pack in readable Purple or Green Colours.
- 7 **Acceptance & Receipt:** It should be submitted in Appropriate Format to the purchasing authority.
- 8 **Delivery Challan** - Should be sent in the name of consignee in duplicate. It should specify Name of Equipment / Mfg. by / packing & quantity.
- 9 **Invoice Copy** - Should be sent in triplicate on the Name of Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd.(Procurement Cell), Mumbai. Along with Bill of Entry and Country of Origin Certificate of the consignment.
- 10 **Other Terms :**
- 1) Warranty: The warranty period shall be for 5 years from the date of commissioning of all equipment supplied as certified by the consignee. After completion of 5 years warranty period Manufacturer/Supplier should give commitment to ensure services and supply of spare part for further 5 years. The successful tenderer must ensure 95% uptime during warranty period. In case of downtime, warranty period will be extended for period of downtime. If the equipment is not attended within 24 hours for Mumbai and 48 hours for other places the supplier will be liable to pay a penalty of 0.07% of purchase cost for every day of delay. Such penalty will be recovered from the amount of security deposit. Certificate of such uptime / downtime issued by the end user will be binding for the supplier Replacement of spares parts thereof due to manufacturing defects during warranty period will be entirely at the supplier's cost.
- 2) The user institution will enter to the Comprehensive Maintenance Contract with supplier agency @ 5% of the Order value (excluding taxes) of the equipment per year for 5 years after completion of warranty period. In case of non-compliance of CMC the supplier will be liable to pay penalty or for appropriate action. Payment of CMC on yearly basis will be made by the user's institution, at the end of the year after satisfactory performance report from the end user.
- 11 **Contract Agreement:** Bidder should submit Contract Agreement on non-judicial stamp paper of requisite value.

Fall Clause

Specification of Autopsy Table (SS)

- Autopsy Workstation made from sturdy and high quality Stainless Steel
- Autopsy Workstation comprises of standard table with raised edges that has faucets and drains which are used to wash away collecting fluids during the internal investigation.
- These work stations should be fully equipped with requisite features to provide a clean hygienic and functional platform for performing autopsy procedures
- Autopsy workstation should be designed with dissection wing and base cabinet to provide extra storage.
- These workstations should have clear hygienic bacteria free work platform space and is free from all rivets and bolts.
- The dimensions of the table should be 225L x 75W x 90H cm.
- The dimensions of the dissection wing should be 155L x 75W x 97 H cm.
- There must be sufficient space for wide access below the table for sanitation and cleaning.
- Two piece construction for easy installation.
- There should be wrist operated stainless steel faucet with hot and cold water flow control valves.
- It should have reverse flow hydro aspirator with built in vacuum breaker.
- The workstation should be equipped with large radius inside corners for easy clean up.
- Autopsy Workstation should have 4 solid stainless steel sliding body supports with wooden head rest.
- There should be engraved measurement scale on one side for easy measurement of cadaver
- Workstation should be L shaped; so on long arm body dissection and short on Tissue dissection can be done. Each arm should have separate sink.
- Tissue Dissection arm should be provided with wooden Block for tissue dissection.
