- 4 **Risk purchase clause:** If the bidder fails to supply the stores within the stipulated delivery period, the order will stand cancelled. Undersigned shall be entitled to purchase such stores from any other source at such price which ordinarily should not be more than 10% of the tender price. The extra expenditure in such cases shall be recovered by Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd. (Procurement Cell), Mumbai from the Supplier.
- 5 **Payment Terms:** Payment of 100% of the contract value will be made within 8 weeks on delivery and successful Installation and satisfactory commissioning and operation of the machinery.
- 6 **Labelling:** The word "**For use of GOVERNMENT OF MAHARASHTRA NOT FOR SALE**" should be printed on each unit pack in readable Purple or Green Colours.
- 7 **Acceptance & Receipt:** It should be submitted in Appropriate Format to the purchasing authority.
- 8 **Delivery Challan** - Should be sent in the name of consignee in duplicate. It should specify Name of Equipment / Mfg. by / packing & quantity.
- 9 **Invoice Copy** - Should be sent in triplicate on the Name of Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd.(Procurement Cell), Mumbai. Along with Bill of Entry and Country of Origin Certificate of the consignment.
- 10 **Other Terms :**
- 1) Warranty: The warranty period shall be for 2 years from the date of commissioning of all equipment supplied as certified by the consignee. After completion of 2 years warranty period Manufacturer/Supplier should give commitment to ensure services and supply of spare part for further 8 years. The successful tenderer must ensure 95% uptime during warranty period. In case of downtime, warranty period will be extended for period of downtime. If the equipment is not attended within 24 hours for Mumbai and 48 hours for other places the supplier will be liable to pay a penalty of 0.07% of purchase cost for every day of delay. Such penalty will be recovered from the amount of security deposit. Certificate of such uptime / downtime issued by the end user will be binding for the supplier Replacement of spares parts thereof due to manufacturing defects during warranty period will be entirely at the supplier's cost.
- 2) The user institution will enter to the Comprehensive Maintenance Contract with supplier agency @ 5% of the Order value (excluding taxes) of the equipment per year for 8 years after completion of warranty period. In case of non-compliance of CMC the supplier will be liable to pay penalty or for appropriate action. Payment of CMC on yearly basis will be made by the user's institution, at the end of the year after satisfactory performance report from the end user.
- 11 **Contract Agreement:** Bidder should submit Contract Agreement on non-judicial stamp paper of requisite value.

Fall Clause

It is a condition of the contract that all through the currency thereof, the price at which you will the supply stores should not exceed the lowest price charged by you to any customer during the currency of the contract and that in the event of the prices going down below the rate contract prices you shall promptly furnish such information to us to enable to amend the contract rates for subsequent supplies.

Sr. No.	Technical Specification for Pediatric Dental Chair
1.	Electrically operated physiological dental chair having easy movements. The chair should be of a smaller size for paediatric patients and they should be colourful and fancy to be appealing to child patients. The dental chair should be printed with cartoon design.
2.	Up and down movement and back rest movement should be motorized. Control switches should be on the tray and foot control. (Dual control)
3.	Dental chair should have ergonomically stress free seat and back rest with collapsible auto loading right side arm.
4.	Head rest should be adjustable for paediatric patient with U-bend grip to provide neck comfort.
5.	Dental chair should have dynamic balance on a sturdy base with rust and corrosion resistant steel material.
6.	Dental chair should be mounted with high and low lumen intensity LED light of 9V/12V two intensity, switch and screen touch sensor operated.
7.	Dental chair should have built in X-ray viewer.
8.	Dental chair unit should be supplied with fixed stainless steel instrument tray.
9.	Dental chair unit should have ceramic spittoon of minimum 24cm radius round bowl having appropriate water supply, drainage system.
10.	Dental chair unit should have high and low vacuum motorized suction with flow control valve; auto drain and auto flush system.
11.	Two way switch facility for filling the tumbler and flushing the basin bowl. It should have water filter (single candle type) for connection.
12.	Dental chair unit should have internationally accepted designs with material (steel and other material as per the component requirement) of ISI/ISO accepted standards.
13.	Dental chair should be supplied with Euro mould operator stool having backrest, pneumatic piston for height adjustment.
14.	Dental chair unit should be supplied with floor rubber mat.
15.	Dental chair unit should have two 3 way syringes for air and water spray, with two autoclavable nozzles. (One with control box)
16.	The chair should be supplied two airtor points(w/o Hp), air motor (w/o Hp), brushless Non optic micromotor (w/o Hp), and one Airtor hand piece mini head with head size not more than 9mm in diameter and height should be less than 1cm One airtor and one micromotor.
17.	Control box should be fitted with: <ul style="list-style-type: none"> • Transparent water tank with tubing and nut for fitting with foot control fitted with valves and regulator constant pressure • Transparent water booster

18.	Module system should be suspended.
19.	Dental chair unit should be supplied with LED light cure unit. It should have variable intensity selection (1200-2500mw/cm ²), with a slow start to reach maximum intensity on digital radiometer. It should have a microprocessor controlled light cure unit with digital timer up to 60 seconds, continuous working, and self-problem detection. Overheat protection and cool light for patient comfort. Should be 11 mm in diameter and have a 360 degree rotatable light guide.
20.	It should be supplied with piezoelectric scalers unit with three regular scaling tips (Inbuilt).
21.	It should have an autoclavable hand piece
22.	It should have Power settings in a wide range
23.	It should have Piezo-electric ultrasonic generator with the frequency of 27-36 kHz
24.	It should have an easy access adjustable spray
25.	It should have an automatic feedback control system adjusting to optimum frequency at tip
26.	FiberOptic airtor
27.	Synchronized movement
