- 2 Delivery Period:** 12 weeks from the date of receipt of order by the supplier to the consignee attached.
- 3 Pre-Dispatch Inspection:** Supplier shall make necessary arrangement / facilitate to carry out Pre-Dispatch inspection as per Tender Terms & condition and submit the Inspection report to this office. The Pre-Dispatch inspection cost will be borne by supplier. Machine should be dispatched only after satisfactory Pre-Dispatch Inspection.

- 4 **Risk purchase clause:** If the bidder fails to supply the stores within the stipulated delivery period, the order will stand cancelled. Undersigned shall be entitled to purchase such stores from any other source at such price which ordinarily should not be more than 10% of the tender price. The extra expenditure in such cases shall be recovered by Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd. (Procurement Cell), Mumbai from the Supplier.
- 5 **Payment Terms:** Payment of 100% of the contract value will be made within 8 weeks on delivery and successful installation and satisfactory commissioning and operation of the machinery.
- 6 **Acceptance & Receipt:** It should be submitted in Appropriate Format to the purchasing authority.
- 7 **Delivery Challan** - Should be sent in the name of consignee in duplicate. It should specify Name of Equipment / Mfg. by / packing & quantity.
- 8 **Invoice Copy** - Should be sent in triplicate on the Name of Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd.(Procurement Cell), Mumbai. Along with Bill of Entry and Country of Origin Certificate of the consignment.
- 9 **Other Terms :**
 - 1) Warranty: The warranty period shall be for 2 years from the date of commissioning of all equipment supplied as certified by the consignee. After completion of 2 years warranty period Manufacturer/Supplier should give commitment to ensure services and supply of spare part for further 8 years. The successful tenderer must ensure 95% uptime during warranty period. In case of downtime, warranty period will be extended for period of downtime. If the equipment is not attended within 24 hours for Mumbai and 48 hours for other places the supplier will be liable to pay a penalty of 0.07% of purchase cost for every day of delay. Such penalty will be recovered from the amount of security deposit. Certificate of such uptime / downtime issued by the end user will be binding for the supplier Replacement of spares parts thereof due to manufacturing defects during warranty period will be entirely at the supplier's cost.
 - 2) The user institution will enter to the Comprehensive Maintenance Contract with supplier agency @ 5% of the order value (excluding taxes) of the equipment per year for 8 years after completion of warranty period. In case of non-compliance of CMC the supplier will be liable to pay penalty or for appropriate action. Payment of CMC on yearly basis will be made by the user's institution, at the end of the year after satisfactory performance report from the end user.
- 10 **Contract Agreement:** Bidder should submit a tripartite (Importer, Manufacturer and Haffkine Bio Pharmaceutical Corporation Ltd.) Contract Agreement on non-judicial stamp paper of requisite value.

Fall Clause

It is a condition of the contract that all through the currency thereof, the price at which you will the supply stores should not exceed the lowest price charged by you to any customer during the currency of the contract and that in the event of the prices going down below the rate contract prices you shall promptly furnish such information to us to enable to amend the contract rates for subsequent supplies.

- 11 The Bidder should submit (within 7 days) amount of 1.5% i.e. **Rs. 35,040/-** of order value to meet other incidental expenditure and 3% i.e. **Rs. 70,080/-** as Security Deposit in form of Bank Guarantee. The Bank Guarantee valid for 2 months after the expiry of date of warranty issued by any Nationalized / Scheduled Bank.

Annexure-X

Specification of Fully Motorised Automatic Rotary Microtome


1. The microtome must be suitable for all applications in routine use, research and industry.
2. The instrument offered should be European Origin, the country of origin certificate endorsed by the respective country embassy should be submitted along with the tender.
3. The specifications head should have visual colour coded rings to indicate the movement possible to indicate the start position, travel position.
4. The surface of the housing and selection waste tray should be fully anodized and easy to clean.
5. The instrument should have touch screen display with control wheel settings/toggle at one point operation.
6. Electro-Mechanical control wheel for forward/backward movement, switch ON/OFF the sectioning motor controlling sectioning speed and section/trimming settings.
7. All electronic setting and function of microtome should be operated by a modern touch screen system i.e cutting window, memory function, sectioning mode, section counter, section thickness addition, fine, trim & refraction valve.
8. The instrument should keep the first cut position in its memory and should reach the first cut position at a press of a button.
9. Cutting window enables to reduce the sectioning speed only at the time where specimen block touches blade during sectioning.
10. The microtome should have robust object and knife/blade holders operating in combination with the horizontal and vertical cross- roller bearing & forces balance system.
11. The micro should not have any recurring cost involved after purchases like pressure plate, etc
12. The smooth running handwheel should be lockable in any position and the lock button should be enclosed sliding type for ease in usage. The handwheel should be enclosed in the body of the microtome.
13. The microtome should have colour marked finger guard for additional safety in the area of the knife/blade edge.
14. The microtome should have smooth-running hand wheel with removable handle to ensure maximum user safety during motorized sectioning.
15. The microtome should immediately stop by pushing the emergency stop button.
16. Sample should be positioned quickly and easily on the X and Y axes using the object orientation system and the color marked zero position indicators.
17. The waste produced during sectioning should be caught by the integrated section waste tray and then easy to discard. Section waste tray preferably anodized for proper cleaning.

18. Below are the setting required for microtome:
 - A. Section thickness: 0.5-100 μm increment
 - B. Setting range: 0.5-10 μm in 0.5 μm steps, 10-20 μm in μm in 5 μm steps, 50-100 μm in 10 μm steps
 - C. Trimming mode: 1-500 μm in 1 μm steps.
 - D. Retraction: 0-100 μm in 5 μm steps.
19. The microtome should have object orientation in x and y axes universal 8° and z axes up to 360° with zero point indicator.
20. The microtome should have sectioning mode manual, continuous, single and step
21. The sectioning speed should be continuously adjusted from 0 to 300 mm/sec
22. Coarse feed speed should be 1.7 mm/s
23. Remaining feed indication 1 mm horizontal should be visual and audible.
24. The microtome horizontal range should minimum 24 mm or more
25. The microtome vertical range should be minimum 70 mm
26. The microtome should include: 1 Disposable low profile blade holder complete, High profile blade pak 50 blade low profile blade pack (50 packet each) 1 section waste tray, 1 Protective cover, 1 operating manual, 1 object clamp orientable.
27. The instrument should be certified with CE or USFDA registration.
28. The instrument should have both high & low profile disposable blade holder with lateral displacement & standard clamp head & accessories.
