Sanitary Napkin (70)	Sanitary Napkin consists of an outer covering provided with sufficient number of channels for leak protection and an absorbent filter material with an adhesive back strip.B.Description1.covering-The covering of the absorbent filler shallbe made of good quality perforated polyurethane film sleeve which has sufficient porosity to permit the assembled napkin to meet the absorbency requirements. This shall be made of a product that is non-allergenic and biocompatible. The sanitary napkins shall have non-absorbent barrier on one side which shall have an identifying mark. Indicating clearly the side of barrier. 2. Absorbent Filler- The filler material shall consist of cellulose pulp (either based on wood or paper or poly-acrylate gels). This shall be free from lumps, oil spots, dirt or foreign material etc. 3. Back Strip-A back strip for sticking the sanitary napkin onto the underwear should be there using good quality adhesive material. 4. Absorbency- the sanitary napkin should be able to absorb not less than 30ml of normal saline (1.P)@15ml/minute. 5.
