- 4 **Risk purchase clause:** If the bidder fails to supply the stores within the stipulated delivery period, the order will stand cancelled. Undersigned shall be entitled to purchase such stores from any other source at such price which ordinarily should not be more than 10% of the tender price. The extra expenditure in such cases shall be recovered by Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd. (Procurement Cell), Mumbai from the Supplier.
- 5 **Payment Terms:** Payment of 100% of the contract value will be made within 8 weeks on delivery and successful installation and satisfactory commissioning and operation of the machinery.
- 6 **Labelling:** The word "**For use of GOVERNMENT OF MAHARASHTRA NOT FOR SALE**" should be printed on each unit pack in readable Purple or Green Colours.
- 7 **Acceptance & Receipt:** It should be submitted in Appropriate Format to the purchasing authority.
- 8 **Delivery Challan** - Should be sent in the name of consignee in duplicate. It should specify Name of Equipment / Mfg. by / packing & quantity.
- 9 **Invoice Copy** - Should be sent in triplicate on the Name of Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd.(Procurement Cell), Mumbai. Along with Bill of Entry and Country of Origin Certificate of the consignment.
- 10 **Other Terms :**
- 1) Warranty: The warranty period shall be for 2 years from the date of commissioning of all equipment supplied as certified by the consignee. After completion of 2 years warranty period Manufacturer/Supplier should give commitment to ensure services and supply of spare part for further 8 years. The successful tenderer must ensure 95% uptime during warranty period. In case of downtime, warranty period will be extended for period of downtime. If the equipment is not attended within 24 hours for Mumbai and 48 hours for other places the supplier will be liable to pay a penalty of 0.07% of purchase cost for every day of delay. Such penalty will be recovered from the amount of security deposit. Certificate of such uptime / downtime issued by the end user will be binding for the supplier Replacement of spares parts thereof due to manufacturing defects during warranty period will be entirely at the supplier's cost.
- 2) The user institution will enter to the Comprehensive Maintenance Contract with supplier agency @ 5% of the order value of the equipment per year for 8 years after completion of warranty period. In case of non-compliance of CMC the supplier will be liable to pay penalty or for appropriate action. Payment of CMC on yearly basis will be made by the user's institution, at the end of the year after satisfactory performance report from the end user.
- 11 **Contract Agreement:** Bidder should submit a tripartite Contract Agreement on non-judicial stamp paper of requisite value.

**Fall Clause**


It is a condition of the contract that all through the currency thereof, the price at which you will the supply stores should not exceed the lowest price charged by you to any customer during the currency of the contract and that in the event of the prices going down below the rate contract prices you shall promptly furnish such information to us to enable to amend the contract rates for subsequent supplies.

### Specifications For Bed side Locker

1. **Overall size:** 405mm(L) X 405mm(W) X 820mm(H) Height from Ground level to top.
2. **Top & Frame, Legs:**
  - a. Top S.S. sheet 18SWG, with raised edges upto 25mm, at three side, double bend on front side.
  - b. Top must be fitted to the frame.
  - c. Frame S.S. tubular 25 mm X 25mm, 18SWG, at the bottom nylon shoes.
3. **Locker:**
  - a. Five side of locker should be covered by S.S. sheet 20SWG, three side must be machine pressed by single S.S. sheet. Fitted internally on vertical legs.
  - b. Door- S.S. sheet 20SWG, double bended, having 100mm “D” shape S.S. handle must be welded & have hinges to freely open.
  - c. **“Govt. of Maharastra Public health Dept. & Mfg date”** must be embossed at visible sight, must be easily readable.
4. **Finish:**
  - a. All S.S. should be deep fully argon seamless welded and polished finished.
  - b. Tow section tops should be smooth edges and burr free and corners should be round off so that there should be no sharp corners.
5. **General Requirements:**
  - a. All stainless steel sheet & stainless steel tubes/pipes used in manufacturing shall be of **304 S2** grade confirming to IS 6911 of 1992 or latest.
  - b. All dimensions will be considered – Length, Width, Height in millimetre(mm), thickness in gauge (SWG – standard Wide Gauge), Diameter should consider as outer Diameter (OD).
  - c. The bed side locker must be sturdy, vibration free and self balance.
  - d. The bed side locker shall be properly constructed with all welded joints grounded, cleaned and well-formed. Unless otherwise specified, the vertical members shall be perpendiculars to the wheel base and parallel to each other and the horizontal members shall be at right angles to the vertical members.
  - e. The bed side locker shall stand on all the legs at the same time on a level surface. All the surfaces shall be smooth and free from pitting. Welding shall fully penetrate and shall be sound in every detail and it shall finished stage, there shall be no exposed sharp edges in the frame-work or other unsealed formations which may harbour dirt or foreign matter.
  - f. The sketch shown in the specification is only indicative for the bidder.
  - g. Tender committee has reserved rights to change dimensions & sketch at any stage of tender.
