- 4 **Risk purchase clause:** If the bidder fails to supply the stores within the stipulated delivery period, the order will stand cancelled. Undersigned shall be entitled to purchase such stores from any other source at such price which ordinarily should not be more than 10% of the tender price. The extra expenditure in such cases shall be recovered by Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd. (Procurement Cell), Mumbai from the Supplier.
- 5 **Payment Terms:** Payment of 100% of the contract value will be made within 8 weeks on delivery and successful installation and satisfactory commissioning and operation of the machinery.
- 6 **Labelling:** The word "**For use of GOVERNMENT OF MAHARASHTRA NOT FOR SALE**" should be printed on each unit pack in readable Purple or Green Colours.
- 7 **Acceptance & Receipt:** It should be submitted in Appropriate Format to the purchasing authority.
- 8 **Delivery Challan** - Should be sent in the name of consignee in duplicate. It should specify Name of Equipment / Mfg. by / packing & quantity.
- 9 **Invoice Copy** - Should be sent in triplicate on the Name of Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd.(Procurement Cell), Mumbai. Along with Bill of Entry and Country of Origin Certificate of the consignment.
- 10 **Other Terms :**
- 1) Warranty: The warranty period shall be for 2 years from the date of commissioning of all equipment supplied as certified by the consignee. After completion of 2 years warranty period Manufacturer/Supplier should give commitment to ensure services and supply of spare part for further 8 years. The successful tenderer must ensure 95% uptime during warranty period. In case of downtime, warranty period will be extended for period of downtime. If the equipment is not attended within 24 hours for Mumbai and 48 hours for other places the supplier will be liable to pay a penalty of 0.07% of purchase cost for every day of delay. Such penalty will be recovered from the amount of security deposit. Certificate of such uptime / downtime issued by the end user will be binding for the supplier Replacement of spares parts thereof due to manufacturing defects during warranty period will be entirely at the supplier's cost.
- 2) The user institution will enter to the Comprehensive Maintenance Contract with supplier agency @ 5% of the order value of the equipment per year for 8 years after completion of warranty period. In case of non-compliance of CMC the supplier will be liable to pay penalty or for appropriate action. Payment of CMC on yearly basis will be made by the user's institution, at the end of the year after satisfactory performance report from the end user.
- 11 **Contract Agreement:** Bidder should submit a Contract Agreement on non-judicial stamp paper of requisite value.

Fall Clause

Specification of Dental Chair Unit with all Accessories

1. Body contoured electrically operated dental chair unit, having up/down, back/front movement with linear actuators having feather touch controls (doctors tray, foot control and assistant side) and manually operated switches (at the side of patients's backrest for up/down, back/front.) Switches for tumbler and spittoon (doctors tray as well as assistant side)
2. Shockproof gargle and also control by foot for chair movement with synchronized movements. Microprocessor control with safety systems.
3. Chair can be tilted for head low (trendelenberg) position (pre-programmed trendelbarg and zero position)
4. Moulded cushion, laminated artificial leather upholstery with smooth euro moulded collapsible right arm.
5. Wide doctors tray with removable stainless steel tray.
6. Right arm should have rotation/collapsible for easy access for patient.
7. Chair side ceramic spittoon and tumbler, time controlled with bio system.

8. Operating light-

1. Dual control sensor and electronic switch, variable intensity control white LED light with 15000-25000 lux. Switches should be at foot control, doctor's tray and touch sensor at the light.
2. Chair mount modular delivery system with straight tubing for two airtor connection, one micro motor connection, one scaler point, three way syringe unit at doctors tray as well as assistant side with hanging below the tray system, chair mounted LED x-ray viewer
3. Chair should be rigid and sturdy. It should have pneumatic doctors tray which should be stabilized at any position
4. Chair should be ergonomically designed.

9. Pneumatic Doctor's stool with wheels

1. With up and down movement-back rest tilt. Stool should be ergonomically designed.
2. Motorized high and low suctions with auto flushing system, auto drain and auto on/off system.

10. **Air Compressor** - 2 HP noiseless with 50-75 litre capacity, with 50-75 litre capacity, dust and oil free pressure regulator with outlet pressure gauge, pressure indicator with safety valve, odour free air, automatic cut off and protective epoxy paint internally to avoid internal corrosion.


