The Pre-Dispatch inspection cost will be borne by supplier. Machine should be dispatched only after satisfactory Pre-Dispatch Inspection.

- Risk purchase clause: If the bidder fails to supply the stores within the stipulated delivery period, the order will stand cancelled. Undersigned shall be entitled to purchase such stores from any other source at such price which ordinarily should not be more than 10% of the tender price. The extra expenditure in such cases shall be recovered by Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd. (Procurement Cell), Mumbai from the Supplier.
- 5 Payment Terms: Payment of 100% of the contract value will be made within 8 weeks on delivery and successful Installation and satisfactory commissioning and operation of the machinery.
- 6 Labelling: The word "For use of GOVERNMENT OF MAHARASHTRA NOT FOR SALE" should be printed on each unit pack in readable Purple or Green Colours.
- Acceptance & Receipt: It should be submitted in Appropriate Format to the purchasing authority. 7
- 8 Delivery Challan - Should be sent in the name of consignee in duplicate. It should specify Name of Equipment / Mfg. by / packing & quantity.
- 9 Invoice Copy - Should be sent in triplicate on the Name of Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd.(Procurement Cell), Mumbai. Along with Bill of Entry and Country of Origin Certificate of the consignment.

10 Other Terms:

- 1) Warranty: The warranty period shall be for 2 years from the date of commissioning of all equipment supplied as certified by the consignee. After completion of 2 years warranty period Manufacturer/Supplier should give commitment to ensure services and supply of spare part for further 8 years. The successful tenderer must ensure 95% uptime during warranty period. In case of downtime, warranty period will be extended for period of downtime. If the equipment is not attended within 24 hours for Mumbai and 48 hours for other places the supplier will be liable to pay a penalty of 0.07% of purchase cost for every day of delay. Such penalty will be recovered from the amount of security deposit. Certificate of such uptime / downtime issued by the end user will be binding for the supplier Replacement of spares parts thereof due to manufacturing defects during warranty period will be entirely at the supplier's cost.
- 2) The user institution will enter to the Comprehensive Maintenance Contract with supplier agency @ 5% of the Order value (excluding taxes) of the equipment per year for 8 years after completion of warranty period. In case of non-compliance of CMC the supplier will be liable to pay penalty or for appropriate action. Payment of CMC on yearly basis will be made by the user's institution, at the end of the year after satisfactory performance report from the end user.
- Contract Agreement: Bidder should submit Contract Agreement on non-judicial stamp paper of 11 requisite value.

Fall Clause

It is a condition of the contract that all through the currency thereof, the price at which you will the supply stores should not exceed the lowest price charged by you to any customer during the currency of the contract and that in the event of the prices going down below the rate contract prices you shall promptly furnish such information to us to enable to amend the contract rates for subsequent supplies.

The Bidder should submit (within 7 days) amount of 1.5% ie. Rs. 14,956.5/- of order value to meet other incidental expenditure and 3% i-e Rs. 29,913/- as Security Deposit in form of Bank Guarantee. The Bank Guarantee Should be Valid for 2 months after the expiry date of warranty, issued by any Nationalized/Scheduled Bank.

Technical Specification For Grossing Station With Standard Accessories

- 1. The Grossing station should be floor top model with a leg space of 14 inches for comfortable working both in standing and sitting position.
- 2. Workstation construction should be made up of high quality Stainless steel. The working surface including the sink should be of grade 316 of 1.6 mm thick and rest of the body of grade 304 of 1.1 mm thick. The base should have anodized aluminium frames.
- 3. The overall dimensions of grossing station should be W 1830 x D 850 x H2100 mm with deep sink of 300 x 300 mm.
- 4. The station should have matt finish with all corners well ground all corners well ground with no sharp edges.
- 5. The station should have automatic timer control internal rinsing system to rinse the area under the perforated work surface.
- 6. The working surface should be perforated with 5 mm holes and has a removable pan with 3mm holes for sample draining.
- 7. The station should have height adjustable storage shelves above working platform.
- 8. The station should have one pull out faucet of 1.5 meter with aerator for washing and cleaning the samples and grossing area.
- The station should have laboratory grade fittings, swan neck tap with wrist operated levers for hand wash, tap with aerator for washing small biopsies, small biopsy drain mesh with water wash.
- 10. The station should have backdraft/downdraft extraction of fumes near the working area with efficient removal of fumes with an efficient blower inbuilt below the working surface.
- 11. The station should have water proof IP 68 controls/switches and electrical indicators.
- 12. The station should have waste disposer/grinder which is strudy and with stainless steel blades, to avoid drainage blockage.
- 13. The station should have magnetic tool bar for attaching the grossing tools.
- 14. The station should be supplied with Grossing Board with printed scale in X & Y axis and black color spot in the center for easy view and grossing of white color tissue.
- 15. The station should have wheels for easy shifting.
- 16. The station should have provision to attach/upgrade with a dedicated histology macro photography system.
- 17. The station illumination should be a combination of yellow and white LED lights for minimizing reflection and better viewing of tissue.
- 18. The station should have safety ELCB and power inlet.
- 19. The station should have power sockets for plugging of additional applicances like weighing scale, bone saw, camera etc.
- 20. The station should be ISO certified.
