The Pre-Dispatch inspection cost will be borne by supplier. Machine should be dispatched only after Satisfactory Pre-Dispatch Inspection.

- Risk purchase clause: If the bidder fails to supply the stores within the stipulated delivery period, the order will stand cancelled. Undersigned shall be entitled to purchase such stores from any other source at such price which ordinarily should not be more than 10% of the tender price. The extra expenditure in such cases shall be recovered by Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd. (Procurement Cell), Mumbai from the Supplier.
- Payment Terms: Payment of 100% of the contract value will be made within 8 weeks on delivery and successful installation and satisfactory commissioning and operation of the machinery.
- 6 Acceptance & Receipt: It should be submitted in Appropriate Format to the purchasing authority.
- Delivery Challan Should be sent in the name of consignee in duplicate. It should specify Name of Equipment / Mfg. by / packing & quantity.
- 8 Invoice Copy Should be sent in triplicate on the Name of Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd.(Procurement Cell), Mumbai. Along with Bill of Entry and Country of Origin Certificate of the consignment.

9 Other Terms:

- 1) Warranty: The warranty period shall be for 2 years from the date of commissioning of all equipment supplied as certified by the consignee. After completion of 2 years warranty period Manufacturer/Supplier should give commitment to ensure services and supply of spare part for further 8 years. The successful tenderer must ensure 95% uptime during warranty period. In case of downtime, warranty period will be extended for period of downtime. If the equipment is not attended within 24 hours for Mumbai and 48 hours for other places the supplier will be liable to pay a penalty of 0.07% of purchase cost for every day of delay. Such penalty will be recovered from the amount of security deposit. Certificate of such uptime / downtime issued by the end user will be binding for the supplier Replacement of spares parts thereof due to manufacturing defects during warranty period will be entirely at the supplier's cost.
- 2) The user institution will enter to the Comprehensive Maintenance Contract with supplier agency @ 5% of the order value (excluding taxes) of the equipment per year for 8 years after completion of warranty period. In case of non-compliance of CMC the supplier will be liable to pay penalty or for appropriate action. Payment of CMC on yearly basis will be made by the user's institution, at the end of the year after satisfactory performance report from the end user.
- 10 **Contract Agreement:** Bidder should submit a tripartite (Importer, Manufacturer and Haffkine Bio Pharmaceutical Corporation Ltd.) Contract Agreement on non-judicial stamp paper of requisite value.

Fall Clause

Technical Specifications for Vacuum Pump

- Noiseless aspiration unit with rapid Vacuum build up mounted on a well-balanced trolley with equipotential conductor and at least four good quality antistatic castors with brakes.
- System should be capable of operating ar vacuum levels between 0 to -95 kPa/712 mmH
- System should provide selectable air flow rates of 40 L/min, 50 L/min and 60L/min
- The system should be based on glass free heat resistant piston cylinder with flat spring technology
- System should have Membrane Vacuum Regulator
- System should have Clean Touch buttons providing One-touch flow
- Noise level should be below 40 dB at the highest flow rate
- System should be provided with an autoclavable and reusable Safety Jar made up of Polysulfone for protection against entry of fluids inside the machine
- System should be provided with autoclavable and unbreakable Polysulfone Jars of 3 Litres capacity having mechanical overflow protector with auto shut off feature
- Jars should have an autoclavable lid to maintain complete sterility of the unit and should be air tight.
- Two units of 3 Litres Polysulfone Jars should be provided
- Changeover valve should be present for easier switching of vacuum from one jar to other without switching off the machine
- System should have Type CF electrical certification for providing protection against electric shock
- System should be compliant with IP 21-Ingress Protection to prevent ingression of foreign bodies and any type of fluid inside the machine.
- System should have clamp holders for directly clamping the jars on the machine rail without the
 use of screws
- System should have a set of autoclavable medical grade cups as follows
 - 1. 50mm and 60mm silicone cups
 - 2. 60mm caesarean silicone cups
- 50mm Bird Posterior (Occipito Posterior) Cup with a separate traction handle.
- The machine should have continuous duty cycle.
- Integrated Foot on/off switch should be present in the trolley.
- System should be oil free and should not contain any glass or stainless steel components.
- System should be provided with sealed disposable liners of 2.5 litres capacity and made up of
 polyamide and polyethylene along with solidifier and bacterial filter with splash protection for
 closed containment of infected fluids.
- System should have one polycarbonate Jar of 2.5 Litres for fixing of disposable liners
- System should have colour coded LED indicators for status of the machine-Standby, Running and Error
- System should have valid European CE Certificate as per 93/42/EEC directive on MDD and US FDA Certificate
- The Equipment shall have valid ISO 13458 Certificate
- System should have 5 years comprehensive warranty and additional 5 years CAMC should be quoted
- All the components should be from the same manufacturer unless stated.
