- 2 Delivery Period: 12 weeks from the date of receipt of order by the supplier to the consignee attached.
- 3 Pre-Dispatch Inspection: Supplier shall make necessary arrangement / facilitate to carry out Pre-Dispatch inspection as per Tender Terms & condition and submit the Inspection report to this office. The Pre-Dispatch inspection cost will be borne by supplier. Machine should be dispatched only after Satisfactory Pre-Dispatch Inspection.

- Risk purchase clause: If the bidder fails to supply the stores within the stipulated delivery period, the order will stand cancelled. Undersigned shall be entitled to purchase such stores from any other source at such price which ordinarily should not be more than 10% of the tender price. The extra expenditure in such cases shall be recovered by Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd. (Procurement Cell), Mumbai from the Supplier.
- 5 **Payment Terms:** Payment of 100% of the contract value will be made within 8 weeks on delivery and successful installation and satisfactory commissioning and operation of the machinery.
- 6 Acceptance & Receipt: It should be submitted in Appropriate Format to the purchasing authority.
- 7 Delivery Challan Should be sent in the name of consignee in duplicate. It should specify Name of Equipment / Mfg. by / packing & quantity.
- 8 Invoice Copy Should be sent in triplicate on the Name of Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd. (Procurement Cell), Mumbai. Along with Bill of Entry and Country of Origin Certificate of the consignment.

#### 9 Other Terms :

- 1) Warranty: The warranty period shall be for 2 years from the date of commissioning of all equipment supplied as certified by the consignee. After completion of 2 years warranty period Manufacturer/Supplier should give commitment to ensure services and supply of spare part for further 8 years. The successful tenderer must ensure 95% uptime during warranty period. In case of downtime, warranty period will be extended for period of downtime. If the equipment is not attended within 24 hours for Mumbai and 48 hours for other places the supplier will be liable to pay a penalty of 0.07% of purchase cost for every day of delay. Such penalty will be recovered from the amount of security deposit. Certificate of such uptime / downtime issued by the end user will be binding for the supplier Replacement of spares parts thereof due to manufacturing defects during warranty period will be entirely at the supplier's cost.
- 2) The user institution will enter to the Comprehensive Maintenance Contract with supplier agency @ 5% of the order value (excluding taxes) of the equipment per year for 8 years after completion of warranty period. In case of non-compliance of CMC the supplier will be liable to pay penalty or for appropriate action. Payment of CMC on yearly basis will be made by the user's institution, at the end of the year after satisfactory performance report from the end user.
- 10 Contract Agreement: Bidder should submit a tripartite (Importer, Manufacturer and Haffkine Bio Pharmaceutical Corporation Ltd.) Contract Agreement on non-judicial stamp paper of requisite value.

#### Fall Clause

It is a condition of the contract that all through the currency thereof, the price at which you will the supply stores should not exceed the lowest price charged by you to any customer during the currency of the contract and that in the event of the prices going down below the rate contract prices you shall promptly furnish such information to us to enable to amend the contract rates for subsequent supplies.

The Bidder should submit (within 7 days) amount of 1.5% i-e. **Rs. 84,606**/- of order value to meet other incidental expenditure and 3% i-e. **Rs. 1,69,212**/- as Security Deposit in form of Bank Guarantee. The Bank Guarantee valid for 2 months after the expiry of date of warranty issued by any Nationalized / Scheduled Bank.

## Technical Specification for ABG Analyzer

- 1. Fully Automated Arterial Blood Gas Analyser for the analyses of Blood Gas, Electrolyte, Co-oxymetry, Neonatal bilirubin and Upgradeable to Metabolites, shall be having minimum throughput of 30 samples per hours. Shall have in-built thermal printer.
- 2. It should be able to measure PO2, PCO2, pH, Na<sup>+</sup>, K<sup>+</sup>, Cl<sup>-</sup>, ionized Ca++ Hct, tHb, Haemoglobin derivatives: Hhb, O2Hb, Met, Hb, and Sulf Hb, upgradeable to Glu, lac and Barometric Pressure in one single machine with single aspiration.
- 3. Additional Calculated Parameters: total CO2, actual bicarbonates, standard bicarbonate, alveolar Arterial Oxygen Gradient(AaDO2), Oxygen saturation, shunt, MCHC and a total upto 40 calculated parameters including temperature corrected parameters shall be possible.
- 4. Measurement of Hb derivatives with CCD based Polychromator system.
- 5. It should accept whole blood, Serum, Plasma, Dialysate and QC Material.
- 6. Parallel measuring chambers for ABG, Electrolytes and metabolites.
- 7. Sample volume should be less than 200µl.
- 8. Consumables: (As per 100 Samples per day workload for 2 Years)
- a) Reagents
- b) Quality control reagents
- c) Liquid calibrator
- d) Thermal paper
- 9. Should have capability to switch individual module on or off to save reagents and as well as sample volume.
- 10. Fully automatic liquid calibration and no gas cylinders to be used inside or outside the equipment.
- 11. Equipment should have totally maintenance free electrodes (no membrane changing, etc.)
- 12. Reagents upto 3 or 4 containers only to reduce cost per test and reagent inventory.
- 13. Calibration / Washing reagents must be in separate individual bottles for optimum use instead of single sealed pack reagent to avoid the wastage of reagents.
- 14. The machine shall have continuous reagent level monitoring with graphical display.
- 15. Data display on well-illuminated LCD color display with active touch screen and print out on a fast, low noise graphical thermal printer with auto cutter facility.
- 16. Should be able to print ACID BASE graph for better interpretation of results.
- 17. Instrument should have an option of internal Auto QC module for All 3 Levels.
- 18. It should include Barcode reader or scanner.
- 19. IT should have data management facility viz to store, sort, mark, trend data, facility to design report, on board video guidance, multitasking facility, etc.
- 20. Storage facility of measured data in case of power failure, built in data storage facility for at least 10,000 patients.
- 21. Should have standby mode facility for economic operation / low reagents consumption should be possible. (No calibration in standby mode).
- 22. Electrodes and all plastic tubings should be covered under warranty as well as under CMC.
- 23. Tropicalisation:

Operating room temperature: Below 40<sup>0</sup> C.

Storage room Temperature: upto 60°C.

Relative Humidity: up to 90% non-condensing.
