- Pre-Dispatch Inspection: Supplier shall make necessary arrangement / facilitate to carry out Pre-Dispatch inspection as per Tender Terms & condition and submit the Inspection report to this office. The Pre-Dispatch inspection cost will be borne by supplier. Machine should be dispatched only after satisfactory Pre-Dispatch Inspection.

- Risk purchase clause: If the bidder fails to supply the stores within the stipulated delivery period, the order will stand cancelled. Undersigned shall be entitled to purchase such stores from any other source at such price which ordinarily should not be more than 10% of the tender price. The extra expenditure in such cases shall be recovered by Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd. (Procurement Cell), Mumbai from the Supplier.
- Payment Terms: Payment of 100% of the contract value will be made within 8 weeks on delivery and successful installation and satisfactory commissioning and operation of the machinery.
- 6 Acceptance & Receipt: It should be submitted in Appropriate Format to the purchasing authority.
- 7 Delivery Challan Should be sent in the name of consignee in duplicate. It should specify Name of Equipment / Mfg. by / packing & quantity.
- 8 Invoice Copy Should be sent in triplicate on the Name of Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd.(Procurement Cell), Mumbai. Along with Bill of Entry and Country of Origin Certificate of the consignment.

9 Other Terms :

- 1) Warranty: The warranty period shall be for 2 years from the date of commissioning of all equipment supplied as certified by the consignee. After completion of 2 years warranty period Manufacturer/Supplier should give commitment to ensure services and supply of spare part for further 8 years. The successful tenderer must ensure 95% uptime during warranty period. In case of downtime, warranty period will be extended for period of downtime. If the equipment is not attended within 24 hours for Mumbai and 48 hours for other places the supplier will be liable to pay a penalty of 0.07% of purchase cost for every day of delay. Such penalty will be recovered from the amount of security deposit. Certificate of such uptime / downtime issued by the end user will be binding for the supplier Replacement of spares parts thereof due to manufacturing defects during warranty period will be entirely at the supplier's cost.
- 2) The user institution will enter to the Comprehensive Maintenance Contract with supplier agency @ 5% of the order value (excluding taxes) of the equipment per year for 8 years after completion of warranty period. In case of non-compliance of CMC the supplier will be liable to pay penalty or for appropriate action. Payment of CMC on yearly basis will be made by the user's institution, at the end of the year after satisfactory performance report from the end user.
- 10 Contract Agreement: Bidder should submit Contract Agreement on non-judicial stamp paper of requisite value.

Fall Clause

It is a condition of the contract that all through the currency thereof, the price at which you will the supply stores should not exceed the lowest price charged by you to any customer during the currency of the contract and that in the event of the prices going down below the rate contract prices you shall promptly furnish such information to us to enable to amend the contract rates for subsequent supplies.

The Bidder should submit (within 7 days) amount of 1.5% i-e. **Rs. 62,888.1/-** of order value to meet other incidental expenditure and 3% i-e. **Rs. 1,25,776.2/-** as Security Deposit in form of Bank Guarantee. The Bank Guarantee valid for 2 months after the expiry of date of warranty issued by any Nationalized / Scheduled Bank.

Annexure-X

Specification for Motorised ICU Bed

- A. Overall Size: Approx 2290mm X 1065mm (90"X42") (Buffer to Buffer)
- B. Bed Platform frame size 2230mm x 990mm, 88.8"x39"
- C. The Fully motorized Bed allows the Trendlenburg positions, Reverse Trendlenburg positions, Lateral tilt left, Lateral tilt right, Knee rest position, Back rest positions and Height adjustment controlled through the corresponding electro-mechanical actuators and it is adjusted by soft touch hand operator wired remote control system and has noiseless operations and also has the facility to adjust all the same positions by Nursing Control Panel at foot end.
- D. Roto-translating Back and foot end where in back rest section moves back as it goes up preventing the patient from being pushed downwards as in traditional bens simultaneously even the food end moves away from the center of the bed so that the patient is more comfortable.
- E. Base frame mainly made made of 50 x 25 x 2mm (14 G) and 60mm x 30mm x 1.6 (16G) ERW tubes and MS flats size 6mm thick for various supporting links
- F. The bed works on 3 synchronized vertical column system.
- G. The height adjustment without mattress from 495mm to 890mm
- H. All movements are controlled via wired remote control system as well as nurse control system, with digital display on ACP & Embedded Panels on Middle Railing.
- The Motorized Bed top is divided into four fix sections: Head Section, Trunk Section (Back section), Trunk section (lumber section), and leg section.
- J. The Motorized Bed four fix sections top is made up of 18 G CRCA sheet double press bend and uniformly embossed holes from 23 mm diameter can also be provided with ABS top.
- K. The Trendlenburg position is form rest position to 14 degree and reverses Trendlenburg position is from 14 degree rest position.
- L. Easily readable from the indicator provided on railings, Digital Display on ACP
- M. The Motorized Bed Knee frame is made up of 18 GCRCA sheet and welded to 25 mm x 5 mm thick flat section.
- N. The four section frame is made from 30 mm x 30 mm Square ERW tube.
- A. The knee position is from rest position to 30 degree and reverse to the rest position.
- B. The Backrest position is from rest position to 75 degree and reverse at rest position easily readable from the indicator provided on railings
- C. The lateral tilt position should be at least 18 ° on each side.
- D. The Motorized Bed has polymer molded Split type railings to cover full bed lemgth.

- E. Polymer rails are fitted to the back rest and foot and flap and move along with the flaps when positioned. Thus providing maximum safety to the patient. Care should be taken that these rails are not installed to the bottom bed frame.
- F. The Motorized Bed has a telescopic detachable height adjustable 4 pole IV road to mount syringe pumps. There should be four locations on the bed to mount this IV rod.
- G. The Motorized Bed has mobile base with four numbers 125 mm diameter heavy duty non rusting castors with polyurethane tires for longitudinal and lateral movement with smooth and easy central and directional locking arrangement so that the staff can easily handle the movements and the locking of the bed.
- H. Head & Foot board should be made of blow molded poly propylene. Head board and foot board should be with inserts to mount it on bed frame. Removable PP head board and foot board should have cutouts, for better gripping. The board should have provision to paste provision to paste color stickers.
- The Motorized Bed has manual quick release mechanism on either side for back page 20 of 22 section adjustment during emergency situation.
- J. Quick release mechanism on either side of the bed. K. CPR position can also be sought electronically.
- K. Simultaneous Electronical adjustment of backrest and knee rest on ACP and Embedded panel. One touch Key for 'Emergency head Down' on the ACP and outside Embedded panel. Digital degree display through ACP for backrest, knee rest, trendelenburg / Reverse trendelenburg, Lateral tilt and Cardiac chair potions.
- L. The weight of patient will be displayed on ACP with help of Load cells mounted in base frame.
- **M.** Safety alarm such as Railing down, if middle railing is kept down. Patient out of bed Alarm if patient moves out of bed. Nurse assistance call facility provided with ACP and embedded panel.
- **N.** All electro mechanical actuators need to be compatible with class of IP 54/IP 66.Bed should have ISO 60601-2-52 certificate for patient safety.
- O. Patient load Bearing Capacity 240kgs, Four corner rubber buffers of 100MM diam.
- P. Premium single section mattress with 6" thick wave shape on both sides, high quality, high density, flame retardant from with cover fabric beige coloured, flame retardant, antibacterial.

 Bed should have 200mm Extension from Leg end & Mattress for Bed Extension.
- O. Premium single section mattress with 6 inch thick ICU foam mattress
- R. X. High density, flame retardant foam with cover fabric beige colored antibacterial.
