- 3 **Pre-Dispatch Inspection:** Supplier shall make necessary arrangement / facilitate to carry out Pre-Dispatch inspection as per Tender Terms & condition and submit the Inspection report to this office. The Pre-Dispatch inspection cost will be borne by supplier. Machine should be dispatched only after Satisfactory Pre-Dispatch Inspection.

- 4 **Risk purchase clause:** If the bidder fails to supply the stores within the stipulated delivery period, the order will stand cancelled. Undersigned shall be entitled to purchase such stores from any other source at such price which ordinarily should not be more than 10% of the tender price. The extra expenditure in such cases shall be recovered by Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd. (Procurement Cell), Mumbai from the Supplier.
- 5 **Payment Terms:** Payment of 100% of the contract value will be made within 8 weeks on delivery and successful installation and satisfactory commissioning and operation of the machinery.
- 6 **Acceptance & Receipt:** It should be submitted in Appropriate Format to the purchasing authority.
- 7 **Delivery Challan** - Should be sent in the name of consignee in duplicate. It should specify Name of Equipment / Mfg. by / packing & quantity.
- 8 **Invoice Copy** - Should be sent in triplicate on the Name of Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd.(Procurement Cell), Mumbai. Along with Bill of Entry and Country of Origin Certificate of the consignment.
- 9 **Other Terms :**
- 1) Warranty: The warranty period shall be for 2 years from the date of commissioning of all equipment supplied as certified by the consignee. After completion of 2 years warranty period Manufacturer/Supplier should give commitment to ensure services and supply of spare part for further 8 years. The successful tenderer must ensure 95% uptime during warranty period. In case of downtime, warranty period will be extended for period of downtime. If the equipment is not attended within 24 hours for Mumbai and 48 hours for other places the supplier will be liable to pay a penalty of 0.07% of purchase cost for every day of delay. Such penalty will be recovered from the amount of security deposit. Certificate of such uptime / downtime issued by the end user will be binding for the supplier Replacement of spares parts thereof due to manufacturing defects during warranty period will be entirely at the supplier's cost.
- 2) The user institution will enter to the Comprehensive Maintenance Contract with supplier agency @ 5% of the order value (excluding taxes) of the equipment per year for 8 years after completion of warranty period. In case of non-compliance of CMC the supplier will be liable to pay penalty or for appropriate action. Payment of CMC on yearly basis will be made by the user's institution, at the end of the year after satisfactory performance report from the end user.
- 10 **Contract Agreement:** Bidder should submit Contract Agreement on non-judicial stamp paper of requisite value.

Fall Clause

Technical Specification of Orthopedic & Spine Surgery O.T. Table	
1.	The Operating table should be sturdy, vibration free, Electro-hydraulically operated, should have best ABS castor which should be locked during surgeries through Hand control.
2.	The table top should be X RAY translucent for fluoroscopy with C Arm and radiolucent Mattress. It should have the facility to load X ray cassettes to the table or under the table to by using a X ray cassette holder attachment with clamp.
3.	The table should have the facility to operate high, low, lateral left/right, Trendelenburg and reverse Trendelenburg movements, flex and reflex position and longitudinal shift. All the movements should be electro hydraulic and should be operated by cable connected hand control.
4.	Radiolucent five section table top in head section, back section, seat section with perineal cut with facility to seal the perineal cut has to be provided, slit leg section and inbuilt kidney bridge or inclinable back extension which performs the same functions of kidney bridge.
5.	Should have a override control panel function for all major positions and movements over and above cable connected hand control.
6.	All metal components of the table should be made of corrosion resistant aluminium or stainless steel which should be disinfectant proof with four antistatic castors with caps and central locking facility. The base column should have telescopic cover of stainless steel or Fiber glass/ABS laminate to prevent ingress of fluid into the system. The base should have a 5 th Castor for easy mobility should have stainless steel accessory rail on both sides to hold various accessories.
7.	The mattress should be 80 mm viscoelastic foam type seamless and separate for each section. It should be sealed and not stitched.
8.	The remote control should have clearly labelled LED/colour graphic display control panel with push button for main adjustments such as height, lateral, back section, trendelenburg/ reverse trendelenburg, Flex/Reflex and return to basic / O position with indication of load control of the battery sufficient for weekly use. Should also have the longitudinal sliding movement function in hand control.
9.	The table should have interchangeable head and foot plates.
10.	The battery should be capable of providing a backup of 1 week once fully charged or 50 full operations
11.	The table preferably should be integrated with a self-diagnostic program.
12.	Should be supplied with following standard accessories. A. Padded Goepel leg rest with clamps (pair)- 1 pair. B. Aesthesia screen with clamps – 1 C. Shoulder supports pair clamps – 1 D. Padded armrest with straps with clamps – 1 pair E. X-ray cassette tray/holder – 1 F. Body restraint belt – 1 nos. G. Spine Pad H. Fracture attachment for Femur with swivel extension device with adult and paediatric leg holder I. Meniscus positioning device for knee surgeries J. Accessory for Fibula and Tibia Nailing
13.	Technical data: a. Height adjustment – Minimum – 650-700 mm and maximum 1050 mm or above (both maximum and minimum height is without mattress) b. Side tilt +/- 20 degree c. Back section adjustment 70 degree up, 40 degree down d. Leg section adjustment 90 degree down, 20 degree up e. Trendelenburg at least 30-30 degree f. Head rest +45/-45 deg g. Longitudinal shift 300 mm or more. h. Max width 540 mm or better i. Length 2100 mm or better j. The table should be able to take the weight of 250 kg or more in all positions and functions (including reverse orientation) and 400 kgs in normal orientation.
14.	Product should be of international quality should be European CE/ listed on the website of US FDA, the company should provide following a) Electrical IEC60601-1 medical/electrical equipment of safety b) IEC 60601-2-46 for safety of OT tables and c) IEC 60601-1-2 for electromagnetic compatibility for the quoted model documents should be provided.

15. All claims for the compliance should be proved with documentary evidences
16. The manufacturer If Indian origin should have supplied to government run hospital same model or any other model at least 5 no's in the last two years which is functioning well. Also to prove stability and service support installation above 7 to 8 years with satisfactory service report should be submitted.
17. If the manufacturer is a foreign origin, they can show their international experiences, they should have procured order form any one of the government hospitals inside Mumbai directly or through any one of his dealers in the past 24 months and to prove the stability and performance the manufacturer can produce some documents where their product should have been used for more than 8 years in any leading hospitals with satisfactory service report.
18. All the accessories with the quoted model of table should be directly from the manufacturer and no third party accessories will be accepted.
19. For proper service assurance the Indian company quoting for the tender should have their own service team locally, if foreign company then they should have their authorised dealer for services.
20.
