The Pre-Dispatch inspection cost will be borne by supplier. Machine should be dispatched only after Satisfactory Pre-Dispatch Inspection.

- 4 **Risk purchase clause:** If the bidder fails to supply the stores within the stipulated delivery period, the order will stand cancelled. Undersigned shall be entitled to purchase such stores from any other source at such price which ordinarily should not be more than 10% of the tender price. The extra expenditure in such cases shall be recovered by Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd. (Procurement Cell), Mumbai from the Supplier.
- 5 **Payment Terms:** Payment of 100% of the contract value will be made within 8 weeks on delivery and successful installation and satisfactory commissioning and operation of the machinery.
- 6 **Acceptance & Receipt:** It should be submitted in Appropriate Format to the purchasing authority.
- 7 **Delivery Challan** - Should be sent in the name of consignee in duplicate. It should specify Name of Equipment / Mfg. by / packing & quantity.
- 8 **Invoice Copy** - Should be sent in triplicate on the Name of Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd.(Procurement Cell), Mumbai. Along with Bill of Entry and Country of Origin Certificate of the consignment.
- 9 **Other Terms :**
 - 1) **Warranty:** The warranty period shall be for 2 years from the date of commissioning of all equipment supplied as certified by the consignee. After completion of 2 years warranty period Manufacturer/Supplier should give commitment to ensure services and supply of spare part for further 8 years. The successful tenderer must ensure 95% uptime during warranty period. In case of downtime, warranty period will be extended for period of downtime. If the equipment is not attended within 24 hours for Mumbai and 48 hours for other places the supplier will be liable to pay a penalty of 0.07% of purchase cost for every day of delay. Such penalty will be recovered from the amount of security deposit. Certificate of such uptime / downtime issued by the end user will be binding for the supplier Replacement of spares parts thereof due to manufacturing defects during warranty period will be entirely at the supplier's cost.
 - 2) The user institution will enter to the Comprehensive Maintenance Contract with supplier agency @ 5% of the order value (excluding taxes) of the equipment per year for 8 years after completion of warranty period. In case of non-compliance of CMC the supplier will be liable to pay penalty or for appropriate action. Payment of CMC on yearly basis will be made by the user's institution, at the end of the year after satisfactory performance report from the end user.
- 10 **Contract Agreement:** Bidder should submit Contract Agreement on non-judicial stamp paper of requisite value.

Fall Clause

It is a condition of the contract that all through the currency there of, the price at which you will the supply stores should not exceed the lowest price charged by you to any customer during the currency of the contract and that in the event of the prices going down below the rate contract prices you shall promptly furnish such information to us to enable to amend the contract rates for subsequent supplies.

Technical Specification for Fowler Bed

1. Fully motorized functions – Bed should have 4 actuators for electrically operated back section raise, leg section raise, height adjustment, Trendelenburg & Reverse Trendelenburg functions, with standard battery backup.
2. Bed Frame should be made of high grade Electric Resistant Welded Tube (cold rolled Steel in Low carbon grade equivalent to STKM11 Medium tensile), with powder coating finish.
3. Bed frame shall be made mainly from 50mm X 30mm X 1.8mm thick Electric Resistant Welded tubes with proper support.
4. Should have Four sectional easily detachable mattress base made of high grade blow molded HDPE material with perforations for easy breathing of mattress.
5. Should have easily detachable Head Board/Foot Boards (made of blow molded HDPE material with inner ribs with enhanced strength) for easy access to patients.
6. Bed should have entrapment free split side rails (made of HDPE) with anti-tampering Safety Locks.
7. Operational controls should be embedded near head end of both side rails (outside Panel-for Nurse operation & inside panel-for Patient use with limited controls).
8. Bed should have Safety lock button on the outer Operational control panel for limiting the access of the patient controls embedded on inner part of the side rails.
9. Should have electrically operated height adjustment from 350 mm to 700mm.
10. Should have a low bed height LED indicator on the operational control panels for indicating the low height position of the bed.
11. Should have LED indicator on the Operational control panel for indicating the battery charging while connected to power supply.
12. Motorized retracting and elevating backrest movement up to 70° with angle indicators on both side rails. Back section operation should have Stretch Saver Raise mechanism to prevent any pressure buildup on Patient's abdomen.
13. Motorized retracting and elevating Leg section movement up to 25° with angle indicators on both side rails.
14. Should have Trendelenburg is Reverse Trendelenburg operation angle of +/-12°
15. Inorder to bring the bed to flat position during any emergency situations, bed should have One button electric CPR (Yellow colored button, embedded on both operational controls on side rails) & also should have a Manual CPR lever (Yellow colored, connected with wires), on both sides at Head end of mattress base.
16. Bed should be equipped with standard battery backup.
17. Bed should have single button operated Auto contour & Cardiac chair position.
18. Bed should have on Overall size of 2200mm X 990mm, with mattress base size of 2000mm X 860 mm.
19. Should have Bed length extension option of upto 100mm.
20. Should have a safe working load of 230 kg.
21. Should have 4 corner buffers made of rubber material for preventing the Bed from collision to hard surfaces.
22. Should have IV Pole fixation option at all 4 corners of the bed, Should be provided with low carbon grade steel Nickel Chrome plated IV Pole with 2 hooks.
23. Bed should be provided with 100mm Anti0skid, water Proof mattress with Anti-fungal & Anti-bacterial properties. Mattress cover should be easily removable for effective cleaning.
24. All 4 Actuators should be of Linak make.
25. Should have Four 125mm non rusting single wheel Tente casters with Central Lock/ Steer/ Free positions.
26. Power input to be 220-240 VAC, 50Hz as appropriate fitted with Indian plug.
